

**AMDT TO RULES & BYE LAWS : RSI, PUNE**  
(Auth : HQ Southern Comd (EME) Br Noting sheet  
No 1144/Rules & Bye Laws/RSI/2014 dt 06 Sep 2014)

1. Present Rules and Bye Laws of RSI have been notified wef Sep 2013. Few of these Rules & Bye Laws have now been amended with due approval from Chief Patron. Details of the same are as given below and these will be implemented with imdt effect 01 Oct 2014 :-

**Part – I : Rules**

2. **Introduction (Para 1)**

**For** : Rajendra Sinhji Institute (RSI) Pune, situated at No 1 Ashoka Marg, Pune – 411001, has been constructed and equipped with Govt funds to provide social, recreational and sports facilities to serving and ret'd Defence Services Offrs and their families posted or residing at Pune and its nearby Cantts.

**Read** : Rajendra Sinhji Institute (RSI) Pune, situated at No 1 Ashoka Marg, Pune – 411001, has been constructed with Govt funds to provide social recreational and sports facilities to serving and ret'd Defence Services Offrs and their families, posted or residing at Pune and its nearby Cantts.

3. **Membership**

**For** : Service Member (Both active and outstation).

**Read** : Service Member (In station and outstation).

4. **Service Members (Para 10 (a)).**

**For** : All serving Regular offrs of Defence Services holding regular commission.

**Read** : Primarily meant for serving Army Offrs serving in Pune and nearby stations and may accommodate vacancies permitting serving Army offrs from anywhere in the country after which serving Air Force / Naval offrs could be considered.

5. **Note (Para 12).**

**For** : Members mentioned at Para 10 (a) can retain their membership as outstation members on being posted out or shifting residence outside Pune by paying prescribed outstation membership subscription.

**Read** : Members mentioned at Para 10 (a) can retain their membership as outstation members on being posted out or shifting residence outside Pune by continuing to pay the membership subscription. The members are required to intimate the details before moving out/change of station, failure to do the same shall lead to the termination of the membership after adjusting the dues with the security deposit held with RSI.

6. **Associate Members.**(a) **Para 13.**

**For** : The following will be eligible to become Associate Members of the Institute subject to their paying one time non-refundable entry fee and other prescribed subscription and having a house in his/spouse name in Pune. Associate members will not have voting rights.

**Read** : The following will be eligible to become Associate Members of the Institute subject to their paying one time non-refundable entry fee and other prescribed subscription and settled in Pune. Associate members will not have voting rights.

(b) **Para 13 (a)**

**For** : All ret'd Commissioned Offrs of the Defence Services drawing pension.

**Read** : All ret'd Commissioned Offrs of the Defence Services drawing pension (Being an Army Institute ret'd Army Offrs will be given priority over Air Force / Naval Offrs).

(c) **Para 13 (f).**

**For** : Existing serving Permanent Members will be converted to Associate Members on retirement.

**Read** : All existing serving members who were termed Permanent Members will now be grouped under the category of Service Members. They will cease to be Service Members on their retirement. Thereafter, they may be converted to Associate Members subject to their fulfilling the terms & conditions of Associate Members.

7. **Temp Member (Para 15).****Add New Para 15 (c)**

**Walk-in-Membership.** All serving Defence Services Officers (Army/Navy/Air Force) on TD to Pune or satellite stns and their dependants (Spouse & Children) can avail the facilities of Bar & Restaurant only by paying Rs 25/- per head for each entry on production of service I-Card & dependant I-Cards. Dependants are eligible for availing this facility only when accompanied by the offr. Those on I've should take Outstn Membership.

8. **Mgt Committee (Para 23 (c)).**

**For** : 05 Retired Offrs (Associate Members) to be nominated with voting rights.

**Read** : 05 Retired offr's (Associate Members) to be nominated with voting rights at the discretion of Chief Patron for a period of one year at a time. The same member can again re-nominated only once more i.e. an Associate Member can be nominated as Co-opted member only twice in his entire membership tenure with RSI.

9. **Absentee Members (Para 48 (a)).**

**For** : For Service Members only, subscription at the following rates will be levied.

**Read** : For Service Members only, subscription at the following rates will be levied, on submission of a prior written request.

10. **General Rules (Para 130).**(a) **Movie Hall (Para 130).**

**For** : Any member/guest found without ticket by Secy RSI will be charged as under :-

(i)	I <sup>st</sup> Offence	-	Rs 500/-
(ii)	II <sup>nd</sup> Offence	-	Rs 1,000/-
(iii)	III <sup>rd</sup> Time	-	Termination of membership

**Read** : Any member/guest found without ticket by Secy RSI will be charged as under :-

(i)	I <sup>st</sup> Time	-	Rs 500/-
(ii)	II <sup>nd</sup> Time	-	Rs 1,000/-
(iii)	III <sup>rd</sup> Time	-	Termination of membership

(b) **Add new Para 130 (A)****Loss of Card.**

130 (A). On loss of membership card the following will be charged to the members before issue of replacement :-

(i)	I <sup>st</sup> Time	-	Rs 500/-
(ii)	II <sup>nd</sup> Time	-	Rs 1,000/-
(iii)	III <sup>rd</sup> Time	-	Termination of membership

(c) **Add new Para 130 (B)****Controlling of Children.**

130 (B). Any member/Guest unable to control own children from spoiling the premises/causing disturbance to other members will be charged as under by Secy RSI.

(i)	I <sup>st</sup> Time	-	Warning.
(ii)	II <sup>nd</sup> Time	-	Warning.
(iii)	III <sup>rd</sup> Time	-	Termination of membership

(d) **Add new Para 130 (C)****Breakages.**

130 (C). Any member/Guest found to be responsible for breakages of RSI property will be charged as under by Secy RSI :-

(i)	I <sup>st</sup> Time	-	Cost of item/Property + Rs 500/-.
(ii)	II <sup>nd</sup> Time	-	Cost of item/Property + Rs 1,000/-
(iii)	III <sup>rd</sup> Time	-	Cost of item/Property + Termination of membership

(e) **Add new Para 130 (D)****Unbecoming Conduct.**

130 (D). Any member/Guest found acting unbecoming of his/her status as member will be charged as under by Secy RSI :-

(i)	I <sup>st</sup> Time	-	Rs 500/-
(ii)	II <sup>nd</sup> Time	-	Rs 1,000/-
(iii)	III <sup>rd</sup> Time	-	Termination of membership

**For** : Outstation Members – Rs 200/-

**Read** : Outstation Members – Rs 350/-
